Only family members and guests, such as regular dog sitters, listed on this application may use the key fob, and only dogs on this application may be admitted. Key fobs will not be issued until all users on the application have signed it, acknowledging that they understand and agree to all conditions listed. These regulations have been designed with everyone's safety and enjoyment of the park in mind.

THE CITY OF WARREN MAY REVOKE DOG PARK PRIVILEGES FOR MISUSE AT ANY TIME.

OTHER CONDITIONS FOR USE OF WARREN DOG PARK

Owners are legally responsible for their dogs and any injuries caused by their dogs.

Owners must remain within the fenced area at all times.

Dogs must be leashed prior to and upon leaving the dog park.

Dogs with a known history of, or who exhibit aggressive or dangerous behavior are prohibited.

Dogs must be healthy, fully vaccinated (Rabies, DHLPP and Bordetella), de-wormed, licensed and wearing identification tags.

Puppies under four (4) months old are prohibited.

Dogs in heat and pregnant dogs are prohibited.

No people food or drink, or dog food is allowed in the park.

Owners must clean up after their dogs; no fecal waste may be left at the park.

An adult must accompany anyone under eighteen (18) years old. Younger children must be closely supervised.

Children under five (5) are prohibited.

Each person eighteen (18) years and older may bring no more than two (2) dogs into the park at one time.

Dogs must be supervised at all times.

Only dog owners or caregivers and dogs listed on an approved City of Warren Dog Park Application for User Privileges may enter the Dog Park.

The park is open from dawn to dusk.

All key fobs expire every year on April 30th.

Please note that a replacement fee of \$10.00 will be charged for broken, lost or stolen key fobs.

Any violation of the terms of this agreement is a violation of Section 23-16 of the Code of Ordinances of the City of Warren, which states:

Section 23-16. Animals prohibited in parks; exception.

Dogs, cats or other animals within the confines of any park or playground, whether or not the animals are attached to a leash, are prohibited, except by written permission of the Director of Parks and Recreation and as follows:

- a. "Dog Parks"
 - i. Leashed dogs shall be allowed in parks containing a dog park for the purpose of traveling directly to and from the designated dog park area.
 - ii. Dogs, whether leashed or unleashed, shall be allowed in designated dog park areas consistent with posted rules as promulgated by the Director of the Department of Parks and Recreation.

NOTE: Section 23-18 provides that any violation of this ordinance is a municipal civil infraction, which shall not result in the assessment of a fine of not less than one hundred dollars (\$100) or not more than one thousand dollars (\$1000) per violation.

I also agree to defend, indemnify, and hold the City of Warren harmless for any and all such claims of any kind, type, or nature arising from or connected with the use or misuse of the admittance card issued in conjunction with this Application for City of Warren Dog Park Privileges. Such indemnity shall include all legal defense costs of any kind or nature, either rightfully or wrongfully brought or filed by any person or party.

I/WE HAVE READ THE CONDITIONS EXPLAINED IN THIS APPLICATION AND AGREE TO ABIDE BY THEM. I/WE ALSO UNDERSTAND AND ACCEPT THAT THE RULES MAY BE CHANGED FROM TIME TO TIME AND UNDERSTAND THAT ANY CHANGES WILL BE POSTED AT THE DOG PARK.
