\* In accordance with the Warren Code of Ordinances mandated in Section 18-9: No license shall be issued or renewed under the provisions of this chapter or any other ordinance of the city until any and all personal property taxes, levied and assessed against such person by the city which may be due and payable at the time of the filing of the application for such license, shall have been paid (Applies to Warren businesses only) / THIS LICENSE IS NOT TRANSFERABLE & NON-REFUNDABLE

\* Note: New dwelling or new owner must obtain a new Certificate of Compliance from the Building Department

*In accordance with the Warren Code of Ordinances mandated in Section 34-2: No person shall place, sweep, push, shovel or cause to be placed, swept, pushed, plowed or shoveled, any snow or ice from any private property or building upon any street or public way of the city; from any private property or building upon any parking space designated for the use of handicapped individuals as defined in MCL 257.942a; on any parcel of land not belonging to the depositor. This subsection shall not be construed to permit depositing on one's own property if said depositing is prohibited by any other ordinance or statute.*
