- I. CALL TO ORDER: 6:09 pm
- II. ROLL CALL: Sue Keffer, Becky Hetchler, Madelyn Zamora, Chris Werner & Dave Rent.
- **III. ADOPTION OF AGENDA:** Accepted with 0 additions. Motion by David, seconded by Chris. Motion passed.
- IV. MINUTES OF LAST MEETING: Accepted with 0 corrections. Motion by David, seconded by Chris. Motion passed.

V. REPORTS

- A. Chairman: i. Collections: Sue stated that there was nothing new to report. Chris was given a "1987 Macomb County Collection" map. We may have one already but it may not be in as good a condition as the one Chris has. Will check on it. Becky found another casket piece at the cemetery. It will be added to the pieces previously dug up by the groundhogs. Chris stated that the Macomb County courthouse may be replaced and has added our name to be notified if collection pieces may be available. ii: Election of Officers: All current offices have agreed to maintain their positons for the time being. Those are Chair Sue Keffer, (Currently Acting) Vice Chair David Rent, Treasurer Becky Hetchler, Secretary Madelyn Zamora. Motion to accept by Chris, second by Madelyn. Motion passed.
- **B.** Treasurer: i. Treasurer's Report: Becky reviewed the July Purchase Order Status and Financial Reports. She reported that the City Council has approved the budget. Becky has prepared a blanket P.O. with ODP for \$350. Memberships and Dues coming up are Historical Society of Michigan, \$50; Michigan Military Technical & Historical Society, \$35; American Association for State & Local History, \$98. Motion by Madelyn to pay dues of \$183, second by David. Motion passed. Motion by Chris to receive and file Treasurer's report, seconded by Madelyn. Motion passed.
- C. Secretary: i. Correspondence: Madelyn reported receipt of miscellaneous magazines and catalogs.
- D. Warren Historical & Genealogical Society: i. Bunert Schoolhouse: No action to report at Bunert. Chris spoke with the restoration company used by Chesterfield regarding cupola restoration. Chris will send photos and info but the person will be out of town for a while. Chris will contact him again when he returns. a. Fundraiser: Upon receipt of an estimate for the cupola work, Chris will come up with a fundraising plan. b. Website Update: Chris updated information about Bunert and museum open houses. c. Publicity/Facebook: Nothing new to report. d. MMA Workshop: Despite the fact that the workshop to be sponsored by WH&GS has only one person signed up at this time, Chris stated that the prep work must still be done. This includes finding articles and photos from when the schoolhouse was relocated from a bit further north on Bunert to its present location.

This starts with the adoption of a historic preservation ordinance. City Attorney Laura Sullivan will begin working on that and she will prepare the
