- A. SITE PLAN FOR BUILDING ADDITIONS (NORTH AND SOUTH ELEVATIONS) TO AND RECONFIGURING PARKING OF BUDDHIST TEMPLE: Located on the southwest corner of Ten Mile Road and Warner Avenue; 2690 Ten Mile Road; Section 30; Nhung Huynh/Vietnamese Buddhist Association of Detroit; PSP230040.

PETITIONERS PORTION:

Mr. Mason Brown – I'm the Engineer for this project and prepared the site plan.

Mr. Gasper Salvaggi – I'm Gasper Salvaggi, I'm the Contractor for the site.

Mr. Ken Hynuki – I from the Temple.

Mr. Mason Brown – There's an existing Buddhist Temple on the site and the proponent would like to put additions on each end of the building for gathering purposes and hospitality, the area will not be for worship. They want to get the parking reconfigured to accommodate these additions.

1. The written legal description provided does not match the legal description in the site plan.
2. The plan shall show and identify all existing City of Warren underground utilities, sizes and connections in the vicinity of the project.

- B. **SITE PLAN FOR PARKING LOT ADDITION FOR TRINGALI'S BAKERY:** Located on the east side of Schoenherr Road, approximately 150 ft. north of Twelve Mile Road; 29100 & 29080 Schoenherr Road, Section 12; Thomas (Mario) Spagnuolo/Bellissimi Gemelli LLC; PSP230041.

PETITIONERS PORTION:

Mr. Mario Spagnuolo – I own Tringali's Bakery and we've been on that corner since 1970, I have not owned it that whole time. We have purchased the house next door approximately a year and a half ago

with the hope of expanding our parking lot, which since 1970 we probably have not have enough parking there, so this will help alleviate some overfill into the flower shop next door and the subdivision.

- C. **SITE PLAN FOR VIETNAMESE SOCIAL CLUB:** Located on the northwest corner of Thirteen Mile and Mound Road; 5649 and 5651 Thirteen Mile; Section 5; Matt Shango/13 Mile Road. Mound LLC (Donna Ngo/Vietnamese Club); PSP230039.

PETITIONERS PORTION:

Ms. Donna Ngo – We have the business there for a couple of years it's a small family business. We have some coffee and pool tables we charge by the hour. We have private parties together.

Assistant Secretary Chowdhury reads the recommendations:

Ms. Donna Ngo – Yes, if they have 15 people. I serve coffee and they come play pool and they pay by the hour.

Commissioner Robinson – So they'll bring their own?

Ms. Donna Ngo – If they have a party and book like 15 or 10 people they bring their own.

Commissioner Robinson – Thank you.

Assistant Secretary Chowdhury – Is it groups of 15 people in order to book the social event or is it walk-ins or how is it going to be?

Ms. Donna Ngo – They have to book if they come with more than 10 if they come with two or three people, they can play the pool and they pay by the hour. Sometimes there's a big game and they come watch the tv like 10 or 15 people they have to call me first.

Assistant Secretary Chowdhury – So you don't provide any type of food or any type of beverages they bring their own?

Ms. Donna Ngo – Yes.

Assistant Secretary Chowdhury – So are they allowed to bring alcohol?

Ms. Donna Ngo – If they have a party, I don't recommend that. We serve coffee and juice in a can and water.

Assistant Secretary Chowdhury – Is it a certain age limit, I know you said until one o'clock seven days a week. I'm just confused with the times?

Ms. Donna Ngo – Our people work late and they come maybe around eight o'clock and they play pool.

Assistant Secretary Chowdhury – Thank you.

Chair Smith – Do you understand the recommendations?

Ms. Donna Ngo – What you mean recommendations?

Chair Smith – The recommendations that the Planning Director read, do you understand those?

Mr. Ron Wuerth – These are the recommendations they were sent to you, are you okay with all of that?

8. OLD BUSINESS:

MINOR AMENDMENT TO SITE PLAN FOR NEW RECHARGEABLE ENERGY STORAGE SYSTEMS (RESS) AND OFFICE ADMINISTRATION BUILDING PHASE I: Located in the

Southeast corner area of Thirteen Mile and Mound Roads; General Motors Technical Campus; 30470 Harley Earl Road; Section 9; Rodolfo Nieto/General Motors (Michael Serdiuk/Ghafari Associates, LLC). PSP230029. **The minor amendment includes increasing the size of the proposed RESS building and the relocation of the parking area; PMA230012.**

PETITIONERS PORTION:

Mr. Frank Ray – Good evening, Frank Ray, Senior Vice President of Ghafari Associates and Project Director for the project.

Ms. Sara Stanko – Sara Stanko with General Motors.

Mr. Frank Ray – Michael Serdiuk who is the original petitioner is recovering from Covid, so he asked me to step in this evening. The site plan was previously approved for the RESS Building and what is happening with the program is that GM is rearranging the buildings a little bit and the original Admin Building that was on the site is being eliminated and those functions are going to be housed inside the main buildings now.

So what we are asking is that on the RESS Building it's going to be expanding 120 feet to the west and the parking that was on the west side and partially on the front of the property on the north is going to reconfigure to be on the south side in between the two buildings. It's a three-phase program and this is phase one of the three phases. There will be two additional buildings to the south of this facility. They are all intertwined they support each other so they will be done concurrently, and we will be back in front of you for phase II and phase III shortly.

Assistant Secretary Chowdhury reads the following correspondence:

TAXES: Current.

ENGINEERING:

1. This appears to be one phase of a larger area of work on the site. Storm water, detention, and utility calculations should be provided that encompass the full site disturbance.
2. The area of disturbance for this site is greater than one acre and shall comply with the Storm Water Ordinance of the City of Warren. All storm water runoff shall be maintained on the site. Follow the City of Warren Storm Water Standards specified Under Ordinance 80-796. This includes detention, pre-treatment,

bio-retention cells, rate control, and infiltration. Infiltration testing is required on-site.

3. Provide drive aisle width dimensions to ensure they meet City of Warren Standards.
4. Provide details of any work that impacts the Meckler Drian.

MCDR: No Objections.

Mr. Ron Wuerth reads the recommendations of the Staff:

Mr. Frank Ray – I think construction is going to be as soon as we can, mid winter.

Commissioner Robinson – So things are moving along smoothly, that's wonderful.

Mr. Frank Ray – As smooth as they can in the automotive industry.

Chair Smith – I was looking at the drawings on the one item on the back of the blueprints it showed some sort of grass pavers system, or gravel paver system and I didn't see on the drawing where it showed those. It's like little containers that are in like a grid and then you grow the grass out of these they grow four inches or something like that. I didn't see it on the drawing where those are going to be

located but in the itemized plan at the end of the drawing that's where it showed the detail on that. There was one for gravel where you put gravel in it and then there was one where you put grass, it's little round containers that each one of the things go into. It's called grass pavers or something like that?

Mr. Frank Ray – I believe when we had the Admin Building, the office area and the parking associated with it that we had some sustainable paving in that area. So when we removed that parking and removed that Admin Building I think it got deleted from the project, I think that's where that reference comes from.

Chair Smith – So that's not part of this project?

Mr. Frank Ray – No.

Chair Smith – I know you've come before us before and we approved the two buildings and now it's redone again where you're going to have a formation building in the middle, what's the formation building going to be? It's not part of this vote I'm just curious.

Ms. Sara Stanko – Originally the formation was part of the RESS Building and we broke it out into a separate building. The items will move from an existing building to each of the buildings kind of as they go north to be completed into a full battery pack. So it was easier to break it out into a separate stand alone building. Formation will have hardly five occupants, so it really changes the classification of the building.

Chair Smith – Okay thank you. Did you understand all the recommendations?

Ms. Sara Stanko – Yes.
