## Vacating a Public Way and/or Public Utility Easement Procedure

- **Step 1.** Complete the application and submit it to the Planning Department, along with a copy of the subdivision plat in question, requested area to be vacated, and the signed and notarized petition.
- <u>Step 2.</u> Obtain the signatures of a minimum sixty (60%) percent of the owners of land abutting the area to be vacated on the **attached petition.**
- <u>Step 3.</u> The request will be placed on a Planning Commission agenda in accordance with the schedule prepared by the Planning Staff. The applicant will receive a notice informing them of the Planning Commission public hearing scheduled for their item. Attendance at the Planning Commission meeting is **mandatory.**
- <u>Step 4.</u> The Planning Commission will hold a public hearing and issue their recommendation regarding the request. The applicant will receive formal correspondence from the Planning Commission secretary detailing the Planning Commission's recommendation. This recommendation is forwarded to City Council.
- <u>Step 5.</u> The applicant will receive a notice informing them of the City Council public hearing scheduled for their item. Attendance at the City Council meeting is **mandatory.**
- <u>Step 6.</u> City Council will hold a public hearing and either approve, approve with conditions, or deny the vacation request.
- **Step 7.** Any conditions applied to City Council's approval of the request must be completed before the City Clerk will record a certified copy of the resolution with the Macomb County Register of Deeds. Approval of the vacation will be revoked if the applicant does not complete the conditions imposed by the City Council Resolution within two (2) years.
