Would like to see inspections go a step further to ensure resident safety (ovens, microwaves, lint traps, etc.).

Sanford (C116) – A resident in C Building has her family members living with her. What should we do?

Bossenberry (A306) – What about a raise for the Housekeepers?

Hatcher (A310) – A Building has limited parking. B Building residents have been taking all the parking spots.

Clark – B Building currently has the same preventative maintenance program as Stilwell, Buildings A & C will start the same preventative maintenance program July 1st. If you suspect any resident is allowing family to live with them, please report it to the office, we can investigate with the cameras and door fob system to verify. One of the biggest issues facing many of our Seniors is fraud or abuse from family, many times in situations like this, the family member is taking advantage of our Senior resident. The employee's here at Senior Housing piggyback the Attorney's Office contract, who negotiated a larger pay increase than the Housing Commission approved last year, so the employees received a bigger raise than originally intended.

11. Commission Comments

Ostosh – I've received a number of complaints concerning disabled parking, and those spots being taken up or blocked. Is there a way we can police this? With the cold weather, it seems like more people are smoking within their apartments, is there a way we can police this?

Kaercher – Smoking is dangerous, we know that now; unlike when we were younger.

Miller – The bottom line is that each resident signed their lease and no-smoking policy.

Burden – I've spoken with Sean about trying to get a tax preparer here at Senior Housing. If we are able to make that happen, we need to make sure we signup and attend our appointments, because too many times people aren't respectful of the vendor's time. I believe everyone here should consider Renters Insurance, which is extremely affordable.
