Capital Improvement Projects:

Joseph Coach Balconies – prepared for public bid. 27of 165 balconies are locked for safety concerns. Resident safety is our number-one priority. Project costs are estimated at \$2.8 million. I met with the City Controller to issue bonds for upcoming Joseph Coach capital improvements.

Joseph Coach Furnace Room Doors - completed.

Senior Housing Outdoor Lighting – City of Warren Engineering held up the project, but it was released yesterday.

Joseph Coach Make Up Air Units (B & C) – Scheduled to start within next couple months.

Stilwell Manor Pergola – installed by our Maintenance team.

Landscaping – Landscape Services replanted any plantings from last year's project that did not survive, at no charge. They also planted four (4) new trees on North-side of Stilwell Manor and are installing a bench along North-South walkway between Stilwell and Joseph Coach.

SMART Transportation – averaging >8 trips per day, servicing an average of >12 residents. Looking to book a Tigers' game and casino trips in near future.

Warren-Center Line Community Foundation – WHC was presented a check for \$5,000 to enhance the lives of our residents.
