<u>APPROVAL OF AGENDA:</u> A motion by Commissioner R-Marshall, seconded by Commissioner J-Marshall to approve October's Agenda. The motion passed unanimously.

PUBLIC MEETING: Ms. Ludwig stated that she did not have anything to share with the Commission.

<u>CAPTAIN HOUTOS'S REPORT:</u> Captain Houtos reviewed the current crime trends in the City of Warren. Police Officer Moon is doing a fundraiser on October 8th. Go to Buffalo Wild Wings, bring the voucher and 20% of your bill will go towards meals/turkeys for the underprivileged at Thanksgiving.

Community Police Officer Hogue is involved with "S.A.V.E.S (Special Needs, Autism, Vulnerable Person, Elderly, Safety) Project. They work to build better communication between first responders, the community and individuals living with cognitive or developmental challenges. Their goal is to make sure first responders have the tools and information they need before an encounter so every situation can be safer and calmer. A QR Code can be placed in their clothes and shoes to identify them.

Blue Envelope Program is another organization the law enforcement departments are working with. It is designed to help law enforcement officers better interact with individuals with disabilities, such as autism, dementia during traffic stops. This envelope is kept in the vehicle and it contains the individual's identification, vehicle registration and emergency contact information.
