**Clark:** Just to provide the WHC some details of the projects. There are 164 balconies in total, nearly 50% require construction within the next five-years, 27 of them have been deemed unsafe. The project will make long-term updates that will provide additional support structures, and change the balcony railing design in the process. We met with the Controller's Office nearly four months ago to discuss bonding for the project. We are still waiting on that aid.

**Burden:** We should pass the project and send a letter to the Controller and Mayor, asking for expedited assistance in that process. This is a large need for our complex, and we need to get this done.
