CALL TO ORDER: Commissioner Middleswart called the meeting to order at 6:00 pm.

PLEDGE OF ALLEGIANCE: Commissioner Ahmed led the attendees in the Pledge of the Allegiance.

APPROVAL OF MINUTES: A motion by Commissioner Kobir, seconded by Commissioner R-Marshall to approve the Minutes. The motion passed unanimously.

APPROVAL OF AGENDA: A motion by Commissioner Antrikin, seconded by Commissioner J-Marshall to approve December's Agenda. The motion passed unanimously.

PUBLIC MEETING: Ms. Johnson saw the flyer and wanted to know what the Crime Commission discusses.

Mr. Azgard came to tonight's meeting to learn more about the Crime Commission.

Mr. Sylvester attended tonight's meeting with concerns about speeding in his neighborhood.

Mrs. Palowoda stopped by to let the Crime Commission know that the Neighborhood Watch program is going well.

Ms. Ludwig wanted to thank Deputy Commissioner Dillenbeck for taking the mental health issue seriously.

Mr. Pulice attended tonight's meeting to discuss issues with his neighbor.

Ms. Kacsmark works with the fraud department at Target in Warren. She wanted to introduce herself with the proper people that would assist her position at Targets. Captain Houtos stated that he will talk with her after tonight's meeting.

Ms. Bournias stopped by to let the Crime Commission know she is a volunteer for Canine Companions. She is seeking a "Handling position" with Canine Companions. There will be a fundraiser in July.

CORRESPONDENCE: Commissioner Middleswart stated that she spoke with Mayor Stone regarding the approval of our hats and bulletin board. Commissioner Middleswart wanted to thank Commissioners Porvaznick and R-Marshall for all their help.

CAPTAIN HOUTOS'S REPORT: Captain Houtos reviewed the current crime trends in the City of Warren.

CITY COUNCIL EX-OFFICIO REPORT: Ex-Officio Dwyer reviewed the current events that are occurring with the Warren City Council.

TREASURER'S REPORT: Commissioner Porvaznick distributed November's Treasurer's Report. Shop with a Hero – Police / Fire: Commissioner Middleswart that the Shop with a Hero Police Department will be held on Tuesday, December 9th at 6:30 pm at the Meijer located at 12 Mile and Mound. Shop with a Hero Fire Department will be on Wednesday, December 10th at 6:30 pm at the Meijer located at 12 Mile and Mound. Shop with a Hero Police Department be held on Tuesday, December 16th at 6:30 pm at the Meijer located at 10 Mile and Schoenherr.
